FULLERTON FUND MANAGEMENT STRENGTHENS INVESTMENT LEADERSHIP TEAM

Singapore, 20 June 2017 – Fullerton Fund Management Company Ltd ("Fullerton") announced changes to its senior investment leadership team, with the new appointments of Ken Goh as the Head of Equities and Vincent Chan as the Co-Head of Multi-Asset. Vincent's depth of experience will help Fullerton expand its multi-asset offering for the wholesale channel, which includes retail as well as the retirement segments.

Ong Guat Cheng has been promoted to Head of Fixed Income, effective 1 July 2017; she will assume her new responsibilities from Patrick Yeo, CIO and the current Head of Fixed Income. Guat Cheng has been with Fullerton for 14 years, and has delivered a consistent and strong investment track record as the lead portfolio manager of Fullerton's local currency bond strategies. In her expanded role, she will lead the portfolio managers and analysts in Singapore and China, and have investment oversight of all fixed income strategies.
